Compliance

I hereby waive, release, and discharge KFFC, its officers, directors, members, volunteers, flight instructors, employees, and agents from any and all liability, claims, demands, actions, or causes of action whatsoever arising out of or related to any loss, damage, or injury that may be sustained while participating in KFFC activities, whether caused by the negligence of the KFFC or otherwise, to the fullest extent permitted by law.

Licensure, Medical Fitness, Airworthiness & Insurance

I declare that I hold a valid pilot's license or permit for the type of flying that I intend to do, and that if I am the owner or operator of an aircraft, I agree to have appropriate liability insurance coverage with Kakabeka Falls Flying Inc. declared as an "additional insured" on my policy.
